3. **Bidder’s Conference and Mandatory Walkthrough**

A **mandatory** bidder’s conference and walk through will be held at **10:00 AM on Monday, August 24th, 2020** to acquaint all Bidders with the areas to be under construction. All Bidders shall be required to be present in the G Building Conference Room at the prescribed time for the above mentioned conference and walkthrough in order to be eligible to submit a bid.

Prior to the bid walk through all contractors are required to go through the screening process at the main entrance of the hospital (Carmen Avenue). Temperature checks along with questions will be asked related to COVID-19. Once cleared, paperwork will be provided to the contractor which will permit

access into the building. It is advised to give ample time prior to the walk through to go through this mandatory checkpoint.

There is a paid parking lot for contractors to park in on the south west side of the campus (Carmen Avenue). The parking lot is across from the main entrance to the building. Parking outside of this area in non-authorized locations may lead to non-negotiable parking tickets.

4. General Description

Nassau Health Care Corporation is seeking competitive bids from qualified contractors for the remediation of existing space in Nuclear Radiology to support the installation of a new Symbia Intevo Excel System.

The awarded contractor will be single prime and responsible for hiring all sub-contractors to perform necessary work. Scope of work entails general construction and electrical. Please refer to the drawings and specifications for full details on requisite work.

Based on a construction start date of 9/28/2020 there is an anticipated duration of 3-4 weeks for construction. The scheduled delivery date from Siemens, of the Symbia Intevo, is 10/26/2020.

Nassau Health Care Corporation has a 20% MWBE requirement for all construction projects with a 30% goal.

5. General Requirements

The Project is anticipated to be a single prime contract which will include a Project Labor Agreement between the Nassau Health Care Corporation and the Nassau Suffolk Building Trades Council (copy included in Contract Documents)
