### I. Call to Order

Chairman Detor called the meeting to order at 5:03 p.m. and asked Ms. Ryan to take a roll call to ensure there was a quorum.

Mr. Cohn announced that he had received an email from the union saying the meeting was illegal and wanted to make sure that it was legal before they proceeded with it. He said he wanted a statement on the record from the General Counsel, Ms. Ryan, that the meeting was legal and proper.

Ms. Ryan replied that this meeting was a Special Meeting and was duly noticed timely and appropriately and that it was legal and they could move forward.

Chairman Detor asked for a motion to go into executive session.
