 Bids on materials and supplies must be for new items except as otherwise specifically stated in bid or detailed specification.

 Bidder declares that the bid is made without any connection with any other Bidder, submitting a bid for the same items, and is in all respects fair and without collusion or fraud.

4. PRICES The provisions of the New York State Fair Trade Law (Fed-Crawford Act) and the federal price discrimination law (Robinson-Patman Act) do not apply to purchases made by the Nassau Health Care Corporation.

5. SURETY In the event that an award is made hereunder, The Director of Purchase, Nassau University Medical Center, (hereinafter known as the Director of Purchase) reserves the right to request successful bidders to post, within one week, security for faithful performance with the understanding that the whole or any part thereof may be used by the Nassau Health Care Corporation to supply any deficiency that may arise from any default on the part of the Bidder. Such security must meet all the requirements of the County Attorney and be approved by the Nassau Health Care Corporation Attorney.

6. SAMPLES Samples, when required, must be submitted strictly in accordance with instructions, otherwise bid may not be considered. If samples are requested subsequent to bid opening they shall be delivered within five (5) days of the request for bid to have consideration. Samples must be furnished free of charge and must be accompanied by descriptive memorandum invoices indicating if the Bidder desires their return; also specifying the address to which they are to be returned, provided they have not been used or made useless by tests. Award samples may be held for comparison with deliveries.

7. AWARD The Director of Purchase reserves the right before making award to make investigations as to whether or not the items, qualifications or facilities offered by the Bidder meet the requirements set forth herein and are ample and sufficient to insure the proper performance in the event of award. The Bidder must be prepared, if requested by the Director of Purchase to present evidence of experience, ability and financial standing, as well as a statement as to plant, machinery and capacity of the manufacturer for the production and distribution of the material on which he is bidding. Upon request of the Director of Purchase, successful bidder shall file certification from the manufacturer relative to authorization, delivery, service and guarantees. If it is found that the conditions of the bids are not compiled with or that articles or equipment proposed to be furnished do not meet the requirements called for, or that the qualifications, financial standing or facilities are not satisfactory, the Director of Purchase may reject such bids. It is distinctly understood, however, that nothing in the foregoing shall mean or imply that it is obligatory upon the Director of Purchase to make any examinations before award; and it is further understood that, if such examination is made, it in no way relieves the Bidder form fulfilling all requirements and conditions of the bid.

8. Awards will be made to the lowest responsible Bidder. Cash discounts will not be a factor in determining awards, except in tie bids. Consideration will be given to the reliability of the Bidder, the qualities of the materials, equipment or supplies to be furnished, their conformity with the specifications, the purpose for which required and the terms of delivery.

9. The Director of Purchase reserves the right to reject any and all bids in whole or in part and to waive technical defects, irregularities and omissions if in his judgment the best interests of the Nassau Health Care Corporation will be served.

10. Unless otherwise indicated herein, the Director of Purchase reserves the right to make award by items, by classes, by groups of items or as a whole.

11. DELIVERIES Upon failure of the Vendor to deliver within the time specified, or within reasonable time as interpreted by the Director of Purchase, or failure to make replacement of rejected articles, when so requested immediately or as directed by the Director of Purchase. The Director of Purchase from other sources to take the place of the item rejected or not delivered. The Director of Purchase reserves the right to authorize immediate purchase from other sources against rejections on any order when necessary. On all-such purchases the Vendor agrees to promptly reimburse the Nassau Health Care Corporation for excess cost occasioned by such purchases. Should the cost be less, the Vendor shall have no claim to the difference. Such purchases will be deducted from order quantity.

12. An order may be cancelled at the Vendor's expense upon nonperformance. Failure of the Vendor to furnish additional surety within ten (10) days from date of request shall be sufficient cause for the cancellation of the order.

13. When in the determination of the Director of Purchase, the articles or equipment delivered fail to meet Nassau Health Care Corporation specifications or, if in the determination of the Director of Purchase, the Vendor consistently fails to deliver as ordered, the Director of Purchase, reserves the right to cancel the order and purchase the balance from other sources at the Vendor's expense.

14. Delivery must be made as ordered and in accordance with the bid. If delivery instructions do not appear on order, it will be interpreted to mean prompt delivery. The decision of the Director of Purchase, as to reasonable compliance with delivery terms shall be final. Burden of proof of delay in receipt of order shall rest with the

Vendor.

15. The Nassau University Medical Center will not schedule any deliveries for Saturdays,

Sundays or Legal Holidays, except commodities required for daily consumption or where the delivery is an emergency, a replacement, or is overdue, in which event the convenience of the Agency will govern.

16. Supplies shall be securely and properly packed for shipment, according to accepted commercial practice, without extra charge for packing cases, reels, bailing or sacks, the containers to remain the property of the Agency unless definitely stated otherwise in the bid.

17. The Vendor shall be responsible for delivery of supplies in good condition at point of destination. The Vendor shall file all claims with carrier for breakage, imperfections and other losses, which will be deducted from invoices. The receiving Agency will note for the benefit of Vendor when packages are not received in good condition.

18. All supplies which are customarily labeled or identified must have securely affixed thereto the original unmutilated label or marking of the manufacturer.

19. Billings for deliveries must be submitted in detail to Accounts Payable.

 Furniture, machines, and other equipment must be delivered, installed and set in place as directed, ready for use unless otherwise specified.

21. Deliveries are subject to reweighing at destination by the Nassau Health Care Corporation and payment will be made on the basis of net weight of materials delivered. Normal shrinkage will be allowed in such instances where shrinkage is possible. Short weight shall be sufficient cause for cancellation of order at Vendor's expense.

22. GUARANTEES BY BIDDER Bidder hereby guarantees: (a) To save the Nassau Health Care Corporation, its' agents and employees harmless from liability of any nature or kind for the use of any copyrighted or uncopyrighted composition, secret process, patented or unpatented invention, article or appliance furnished or used in the performance hereof of which the Bidder is not the Patentee, assignee or licensee, and to defend any action brought against the Nassau Health Care Corporation in the name of the Nassau Health Care Corporation and under the direction of the Nassau Health Care Corporation Attorney at the sole cost of the Bidder or in the sole option of the Director of Purchase, to pay the cost of such defense to the Nassau Health Care Corporation.

(b) His products against defective material or workmanship and to repair or replace any damages or marring occasioned in transit.

(c) To furnish adequate protection from damage for all work and to repair damages of any kind, for which he or his workmen are responsible, to the building or equipment, to his own work or to the work of other Vendors, or in the opinion of the Director of Purchase, to pay for the same by deductions in payments due under this contract.

(d) To pay for all permits, licenses and fees and give all notices and comply with all laws, ordinances, rules and regulations of the city, village or town in which the installation is to be made, and of the County of Nassau and the State of New York.

(e) To carry proper insurance in the opinion of the Director of Purchase, and approved by the Nassau Health Care Corporation Attorney to protect the Nassau Health Care Corporation from loss in case of accident, fire and theft.

(f) That he will keep himself fully informed of all municipal ordinances and regulations, state and national laws in any manner affecting the work or goods herein specified, and any extra work contracted for by him, and shall at all times observe and comply with said ordinances, laws and regulations, including all provisions of the Workmen's Compensation and Labor Laws, and shall indemnify and save harmless the Nassau Health Care Corporation from loss and liability upon any and all claims on account of any physical injury to persons, including death, or damage to property and from all costs and expenses in suits which may be brought against the same on account of such injuries irrespective of the actual cost of the same and irrespective of whether the same shall have been due to the negligence of the Bidder or his agents or the Nassau Health Care Corporation or their respective agents.

(g) That the items furnished shall conform to all the provisions of the bid and this warranty shall survive acceptance, or use of any material so furnished.

(h) That all deliveries will not be inferior to the accepted bid sample.

23. LABOR LAWS and ANTI-DISCRIMINATION Upon the vendor's acceptance hereof, the vendor agrees to comply with Article IX, Section 2C of the Constitution of the State of New York, Section 220, 220a, 220b, 220d, 220e and 230 of the Labor Law, Section 5 and 12 of the Lien Law, Article 2 of the Uniform Commercial Code, Section 108 and 109 as well as Article 18 of the General Municipal Law, Section 22-4.2 of the Nassau County Administrative Code, the provisions of the Anti-Discrimination Order of Nassau County, and the vendor shall keep himself fully informed of all additional municipal ordinances and regulations, State and National Laws in any manner affecting this order and the goods or services delivered or rendered or to be delivered or rendered thereunder, and shall at all times observe and comply with said ordinances, laws and regulations at his sole cost and expense.

24. To prevent the airborne spread of fungal spores, which may cause disease in susceptible individuals during hospital construction, demolition, and remodeling activities. Construction / renovation require substantial planning to minimize the risk of airborne infection both during projects and after their completion. A multidisciplinary team coordinates Fire Safety and Infection Control risk assessments.

2. Construction / Remodeling Coordination Team

A - The team considers the following prior to initiating any construction or repair activity:

- 1. Design and function of the new structure.
- 2. Assessment of environmental risks for airborne disease and opportunities for prevention.
- 3. Measures to contain dust and moisture during construction.
- B The following disciplines are included:
 - 1. Engineering Department
 - 2. Medical Director and Manager of the involved and adjacent patient care areas
 - 3. Safety and Security Department
 - 4. Infection Control Department
 - 5. Planning Department / Architects
 - 6. Project Managers
- C Responsibility and Accountability
 - 1. Coordinate members' input in developing a comprehensive project management plan.
 - 2. Conduct a risk assessment of the project to determine potential hazards to susceptible patients.
 - 3. Prevent unnecessary exposure of patients, visitors and staff.
 - 4. Oversee all infection control aspects of construction activities
 - 5. Establish site-specific infection control protocols for specialized areas.
 - 6. Ensure compliance with construction standards and any applicable safety regulations.
 - 7. Establish a mechanism to correct problems quickly.
 - 8. Implement "interim life safety measures" as required
 - 9. Infection Control Risk Assessment Procedure.

Instructions

General information

On August 20, 2004, New York State enacted section 5-a of the Tax Law requiring persons awarded contracts valued at more than \$15,000 with state agencies, public authorities or public benefit corporations to certify that they, their affiliates, their subcontractors, and the affiliates of their subcontractors have a valid certificate of authority to collect New York State and local sales and compensating use taxes. A contractor, affiliate, subcontractor or affiliate of a subcontractor must be certified as having a valid certificate of authority if such person makes, or has made, aggregate sales delivered within New York State of more than \$300,000 during the four quarterly periods ending on the last day of February, May, August, and November which immediately precede the quarterly period in which this certification is made. A contractor must use Form ST-220, *Contractor Certification*, to make this certification before the contract may be approved by the Office of the State Comptroller (OSC), or other contract approver if OSC is not required to approve the contract.

This statute applies to contracts resulting from solicitations to purchase issued by governmental entities on or after January 1, 2005. In the case of contracts resulting from issuance of an invitation for bid (IFB) or a request for proposal (RFP), the statute would apply if the IFB or RFP was first issued on or after January 1, 2005. The statute would not apply if the bid document was first issued before January 1, 2005, even if the bid document was amended, or the resulting contract was awarded, approved, amended, or extended after January 1, 2005.

The statute does not apply to purchases from preferred sources. For additional information, please see Publication 222, *Questions and Answers Concerning Tax Law Section 5-a.*

Definition of terms associated with section 5-a

The following is a partial list. Please see Publication 222 for additional information.

A contractor is defined as a person awarded a contract by a covered agency.

The term *person* is defined as any entity in business for either profit or notfor-profit purposes and can refer to an individual, partnership, limited liability company, society, association, joint stock company, or corporation.

A *covered agency* is defined as New York State or any department, board, bureau, commission, division, office, council or agency of New York State; public authorities and public benefit corporations. The State Legislature, the judiciary, Department of Law, Office of State Comptroller, State Education Department, State University of New York and the senior colleges of City University of New York are included in this definition.

An *affiliate* is an entity which, through stock ownership or any other affiliation, directly, indirectly or constructively, controls another entity, is controlled by another entity, or is, along with another entity, under the control of a common parent company.

A *subcontractor* is an entity specifically engaged by a contractor or another subcontractor to provide commodities or perform services necessary to allow a contractor to fulfill a particular contract with a covered agency.

Commodities means, other than with respect to contracts for State printing, material goods, supplies, products, construction items or other standard articles of commerce other than technology which are the subject of any purchase or other exchange.

Tangible personal property means physical personal property, of any nature, that has a material existence and is perceptible to the human senses. Tangible personal property includes, without limitation: (1) raw materials, such as wood, metal, rubber and minerals; (2) manufactured items, such as gasoline, oil, diesel motor fuel and kero-jet fuel, chemicals, jewelry, furniture, machinery and equipment, parts, tools, supplies, computers, clothing, motor vehicles, boats, yachts, appliances, lighting fixtures, building materials; (3) pre-written off-the-shelf software; (4) artistic items such as sketches, paintings, photographs, moving picture films and recordings; (5) animals, trees, shrubs, plants and seeds;

(6) bottled water, soda and beer; (7) candy and confections;

(8) cigarettes and tobacco products; (9) cosmetics and toiletries;

(10) coins and other numismatic items, when purchased for purposes other than for use as a medium of exchange;

(11) postage stamps, when purchased for purposes other than mailing; and (12) precious metals in the form of bullion, ingots, wafers and other forms.

Completing Form ST-220 Identification information

Contractor name: Enter the exact legal name of the person or entity who is contracting to provide commodities or services to a covered agency of New York State. This is the name registered with the New York Department of State.

Contractor's principal place of business: Enter a street address, not a PO box number.

Mailing address: Enter the address where contractor receives mail, if different than the principal place of business.

Contracting state agency: Enter the state agency awarding the contract to the contractor.

Certification statement: If the contractor is a corporation, the statement must be completed by the president, vice president, treasurer, assistant treasurer, chief accounting officer, or other officer authorized by the corporation. If the contractor is a partnership, the statement must be completed by a partner or person authorized by the partnership. If the contractor is a limited liability company, the statement must be completed by a member of the LLC and be authorized by the LLC.

Part I - Contract services not pursuant to Tax Law section 5-a

If the services to be performed under the contract are not services within the meaning of Tax Law section 5-a, mark an *X*. You do not have to complete Parts II through V. You must sign and have the certification acknowledged.

* The purpose of this Bid is to obtain the lowest possible cost and the highest quality for the laundering, pick-up and delivery of patient linens and garments and employee uniform apparel, personal care items and other miscellaneous items, as required on behalf of the NuHealth Corporation and its affiliated facilities, hereinafter referred to as "NuHealth".

* Bids are hereby requested for the pick-up, processing and return of all items. Included in the scope are the following entities: Nassau Health Care Corporation, affiliated Community Health Centers, and the A. Holly Patterson Extended Care Facility. All linens, with the exception of lab coats, will be laundered and delivered folded (bed linens pressed and folded) on exchange carts as per specifications of the NuHealth Corporation. Exchange carts will be provided by the Vendor. *Please specify how many carts will be needed for pick-up, distribution and storage*. Community Health Centers soiled linen to be picked up and returned to the Nassau University Medical Center laundry site. All locations are to be separately packaged and marked. (Addresses listed at end of sealed bid).

PERFORMANCE CRITERIA:

* Please provide information regarding your ability to provide laundry and accompanying services and/or meet the Performance Criteria as set forth below:

1. The Vendor must provide service six (6) days per week Monday – Saturday including holidays.

ALL BIDS MUST BE F.O.B. DESTINATION AND INCLUDE DELIVERY WITHIN DOORS UNLESS OTHERWISE SPECIFIED

2. All soiled linens must be processed and delivered within forty-eight (48) hours,

3. The Vendor must count or weigh the cleaned linen prior to distribution to our facilities.

4. The Vendor must provide a weekly report for linen processed, reflecting the daily weights of soiled linen picked up, the weight of clean linen returned and the wet to clean variance in pounds and percentage.

5. All linens should be treated with a bacteriostatic agent which inhibits the growth of bacteria and effectively kills Staph and E. Coli to help prevent cross infection and contamination. The Vendor should maintain a pH of 4.5 to 6.8 to discourage bacteria growth.

6. The Vendor shall remove all process agents during the rinse cycle so that the last rinse is comparable to tap water.

7. The Vendor shall use sterilizing temperatures which can vary from 180 to 330 degrees Fahrenheit.

8. The Vendor must provide assurances to maintain quality control of the above mentioned factors such as: titration. Bacterial cultures and temperature control charts and maintain an auditable historical information file of these quality control factors for our periodic review.

9. The Vendor shall provide containers to store clean and soiled linens and assure that all containers are cleaned with a disinfectant agent to kill bacteria and eliminate odors.

10. The Vendor must assure that the soiled linens are completely isolated from the clean linens.

11. The Vendor must assure that the room containing the soiled linens must be designed to affect an exchange of air fourteen (14) times per hour to prevent the penetration of dust and contamination.

12. The Vendor shall cover the linen carts with a protective liner to prevent the penetration of dust and wetness.

13. The Vendor shall provide in-service education to NuHealth Corporation personnel, as needed.

14. The Vendor must return reject linens, packaged and properly identified, to NuHealth for final disposal.

15. All services shall be performed as described in this bid. <u>Deviations will not be considered</u> unless the bidder can explain in detail that the deviation is of material benefit to the NuHealth Corporation and provides service levels at least equal to that specified.

16. The Vendor must process all laundry in a manner so as to successfully comply with the chemical and bacteriological analysis that will be routinely conducted by the agency using a State approved independent lab at no charge to NuHealth Corporation.

17. The Vendor will be responsible to have a linen reject credit policy for replacing at no additional cost all laundry that has been insufficiently processed and/or mishandled during initial processing including, but not limited to, the following:

19. All laundry - at the very minimum - will be neatly folded, stacked and packaged for shipment in a manner to ensure a minimum of wrinkling.

20. All laundry is to be <u>tied in bundles</u> and processed as follows:

B. sheets	- ironed and folded
C. blankets	- folded
D. bedspread	- folded
E. gowns & pajamas	- folded
F. towels	- folded

21. All clean laundry must be adequately covered and handled so as to protect the laundry from sources of postprocessing contamination.

22. The Vendor must inspect, and remove all stained, torn, worn and any other substandard laundry, while processing the soiled laundry.

23. The Vendor will provide documentation upon request to the facility of all wash formulas, to include water temperatures, Ph levels, cycle times, and various detergents and Quality Assurance Forms.

24. The Vendor will be required to demonstrate to the facility that the laundering process is tested at least six (6) times per year, for chemical and bacteriological standards. All test results must be provided to: Nassau University Medical Center, 2201 Hempstead Tpke, East Meadow, N.Y. 11554, <u>ATTN</u>: Walter Lazauskas, Laundry. The Vendor shall have an independent State-approved laboratory conduct quality tests on test pieces at least six (6) times per year.

25. The Vendor shall provide NuHealth Corporation with a copy of all tests conducted. A schedule of tests shall be based on the day of commencement of services, and in intervals of two (2) months apart.

26. The Vendor shall make available upon request to the facility, all detergent/chemical/bacteriological test and quality assurance Material Safety Data Sheets on all chemicals used in the disinfection of the trucks and material handling equipment used for deliveries and pickups.

- b. negative air pressure
- c. positive air flow from clean to soiled

35. Soiled sorting room is required to have a minimum of 10 air exchanges per hour exhausting directly outside.

36. **SPECIAL CONDITIONS:** The hampers and carts shall be maintained in good repair, adequately disinfected and properly lined. A sufficient number of hampers will be provided to the facility by the Vendor for pick up of all soiled laundry items, as well as, for the conveyance of clean items. The Vendor's carts shall be distinctly labeled to identify ownership.

37. All material handling carts used to convey "clean" laundry/linen must be properly disinfected prior to receiving clean laundry.

38. All laundry carts used for delivery of processed laundry must be lined, or clean laundry must be shrink-wrapped or wrapped. All processed laundry for delivery must be thoroughly covered from insertion to delivery.

39. All material handling equipment shall be of non-porous material and must be systematically disinfected prior to loading clean laundry.
