In the past few weeks our community has been faced with the COVID-19 pandemic. NHCC rose to the challenge and has cared for hundreds of our family and friends afflicted by this virus.

For those that were not affected by the virus, we instituted a robust telemedicine program to meet their healthcare needs. We recognize that not all healthcare needs can be managed over the phone or via video conferencing so we are in the process of opening our clinics and the hospital in a safe and effective manner.

We have implemented the following 5 strategies to ensure your safety.

1. All patients are checked for possible infection with the virus before entering the hospital.
2. All patients will maintain a distance of at least 6 feet when visiting the hospital and no visitors are allowed except in special circumstances.
3. All employees and patients are required to wear a mask.
4. Hand sanitizers (cleaning solutions for your hands) are available throughout the hospital and our facilities.
5. We will do our best to minimize your waiting time before you see your doctor.

En las últimas semanas nuestra comunidad ha estado enfrentando la pandemia del COVID-19.

Nuestro hospital estuvo a la altura de las circunstancias y ha atendido a cientos de nuestros familiares y amigos afectados por este virus. Para aquellos que no se vieron afectados por el virus, instituímos un programa sólido de telemedicina para satisfacer sus necesidades de atención médica. Reconocemos que no todas sus necesidades de atención médica se pueden atender por teléfono o por videoconferencia y, por lo tanto, estamos en el proceso de abrir nuestras clínicas y el hospital de manera segura y efectiva.

Hemos implementado las siguientes 4 estrategias para garantizar su seguridad.

1. Todos los pacientes son revisados para detectar la posible infección con el virus antes de ingresar al hospital.
2. Todos los pacientes mantendrán por lo menos una distancia de 6 pies cuando visiten el hospital y no se permiten visitas, excepto en circunstancias especiales.
3. Todos los empleados y pacientes deben usar una mascarilla y los desinfectantes para manos (soluciones de limpieza para nuestras manos) están disponibles en todo el hospital.
4. Haremos todo lo posible para minimizar su tiempo de espera antes de ver a su médico.
