### How many years has Nassau Health Care Corporation been self-insured?

NHCC has been self-insured since our separation from Nassau County in 1999.

### What is the number of covered employees that would be under this contract?

NHCC has approximately 3600 employees.

# What is your current gross payroll for those covered employees?

NHCC payroll is in the \$210,000,000 - \$215,000,000 range.

# How does NHCC currently report claims to the TPA?

NHCC utilizes an electronic incident reporting system. Claims are reported to our TPA via email in a .pdf file.



Our Current TPA handles bill review, bill audit, nurse case management for complicated cases/issues. Nurse case management is involved in approximately 50 cases each year.

Employees may be seen in Employee Health Services or in the NUMC Emergency Department. These visits are billed. Some employees opt to use NUMC medical services.

We will respond as quickly and accurately as possible.

# Whether companies from Outside USA can apply for this?

All companies are welcome to respond; however, knowledge of US, NY, and local county laws and regulations is necessary to meet our requirements.

# Whether we need to come over there for meetings?

Face to face quarterly claim reviews have, in our experience, been beneficial in collaboratively overseeing complex cases.

# Can we perform the tasks (related to RFP) outside USA?

It is necessary for TPA staff to be available during standard Eastern USA time zone business hours.

# Can we submit the proposals via email?

Proposals must be submitted in the manner described in the RFP.

# Will NHCC consider alternative language or terms to the proposed standard clauses set forth in Schedule B of the RFP?
