FOR POTENTIAL RESIDENTS AND FAMILY MEMBERS
PUBLIC HEALTH LAW 2803(13)

This notice is intended to heighten awareness among potential residents and their families as to the availability of information maintained by the NYS Department of Health (NYSDOH) and the U.S. Department of Health and Human Services/Centers for Medicare and Medicaid Services (CMS) regarding quality and safety compliance data for residential health care facilities.

Both the NYSDOH and CMS maintain information on nursing homes that includes performance on quality measures, complaints, inspection results, citations and enforcement actions, and any penalties imposed on a nursing home. CMS has created a tool called Care Compare to help consumers search for and select nursing homes and other health care providers, and the NYSDOH maintains a website called Nursing Home Profiles.

According to CMS, the information it maintains on nursing homes should be used with other information you gather about providers and facilities in your area. In addition to reviewing the Care Compare information, you should talk to your doctor, social worker, or other health care providers when choosing a nursing home/provider.
